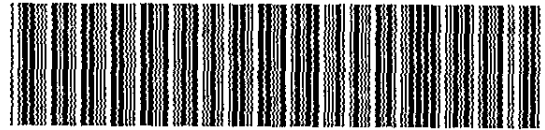

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I - NAME

ARTICLE III - PURPOSE

The specific purpose for which the corporation is organized is:

To support the enactment of laws which advance the common interests of the membership.

To assist and collaborate with all other organizations and/or agencies desirous of achieving these purposes.

ARTICLE IV - MANNER OF ELECTION

The manner in which directors are elected or appointed is:

By ballot of all members in good standing and eligible to vote. Also, committee chairperson(s) are appointed Director(s) by the President and approved by a majority of the Board of Directors.


