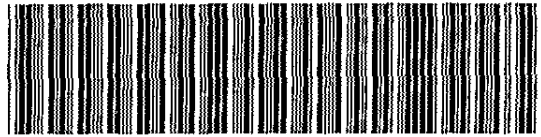

ARTICLES OF INCORPORATION
OF
CITY WIDE EVANGELISTIC OUTREACH MINISTRY, INC.

The undersigned, acting as incorporator of a corporation under the Florida Statutes, adopts the following Articles of Incorporation:

Article I

The name of this principal corporation is **CITY WIDE EVANGELISTIC OUTREACH MINISTRY, INC.**

Article II Purpose (s)

This Corporation is a non-profit public benefit Corporation and is not organized for the principle gain of any person. It is organized under the non- profit Public Benefit Corporation Law for Charitable and Educational purposes. The purpose of this ministry is to enlighten the communities and bring to their awareness that we are in agreement with the word of God, in reconciling man back to God. We will assist the communities by aiding those that are in need of support through a variety of services such as food, clothing, counseling, shelter and etc., and to reach out to the lost souls that has taken the wrong avenue. Also the purpose is to enhance them with the appropriate information that would sustain and help them live a better and productive life.

Article III

The address of the registered agent of the corporation is 4192 Gallimore St. Orlando, Fla. 32811. The name of the registered agent is Jewell Cooper of **CITY WIDE EVANGELISTIC OUTREACH MINISTRY, INC.**

Article IV

The period of duration is perpetual. The corporation is organized pursuant to the Not for Profit Corporation laws of the State of Florida. There should be no stock and will have no members.

Article V

This Corporation is organized and operated exclusively for Religious, Charitable and Education purposes with the meaning of section 501©(3) of the Internal Revenue Service Code.
Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code or by corporation contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code.

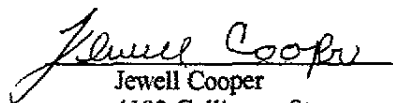
Article VIII

Upon dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for, religious, charitable and education under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
