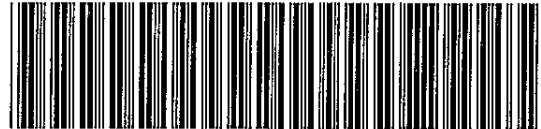

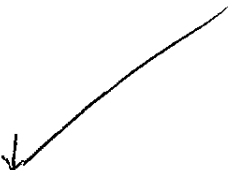

The undersigned, for the purpose of forming a not for profit corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation.

ARTICLES I

NAME

The name of the corporation shall be Temple of Refuge Ministries, Inc.

ARTICLES II

PRINCIPAL OFFICE

ARTICLES III

PURPOSE

The corporation is organized to provide a place of worship for all members of society.
