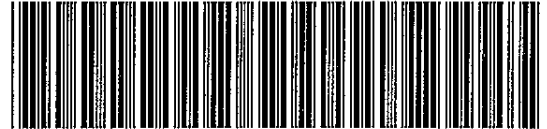

ARTICLES OF INCORPORATION OF
FLORIDA/SAR-EL VOLUNTEERS FOR ISRAEL, INC.,
A NOT FOR PROFIT CORPORATION

The undersigned, with other persons being desirous of forming a not for profit corporation, agrees as follows:

ARTICLE I The name of the corporation is Florida/SAR-EL Volunteers for Israel, Inc., a not for profit corporation. It is chartered under the provisions of Chapter 617 of the Florida Statutes.

ARTICLE II The street address of the initial principal office is: 6501 W. Sunrise Boulevard, Plantation, Florida 33313.

ARTICLE III The corporation is not for profit. Its principal purpose is to recruit volunteers to serve, without compensation, as civilian, non-combatants at military bases, hospitals and other facilities in the State Of Israel. Also, to exercise all common law and statutory powers reasonably necessary to implement its purposes. No part of any income derived shall be distributed to its members, directors, or officers.

ARTICLE IV The corporation shall have twenty-one members who shall serve as directors initially. Thereafter, the corporation shall have no less than eleven directors and no more than twenty-one directors. Vacancies to the board shall be filled by the remaining members of the board of

directors acting through an executive committee of five who shall serve as president, first vice president, second vice president, treasurer, and secretary respectively. Membership shall include persons who from time to time become members voluntarily.
