The purpose of this letter is to give explanation as to why I did not submit my reinstatement application along with corresponding fee. After talking with my accountant and landlord, we figured out that during the time when the post cards were mailed notifying us of corporation renewals, we had already moved from Suite #221 to Suite #216. I subsequently notified the Division of Corporations that my Suite had changed. Unfortunately, the new tenants of #221 also do Immigration Services and are not very professional. We did a change of address with the Plantation Office post office, but there appears to be some (very few) correspondence that continues to be mailed to Suite #221.

I have spoken to the owner of that business, as they are jeopardizing us, not only with the corporation, but with my clients as well. On several occasions I have found clients mail on top of mail box, outside. I have notified the Landlord, as this is not professional and ethical behavior, and they have assured me this will not happen again.

I am requesting that the penalty fee be waived; due to the difficulty I've had receiving my correspondence on time. I feel and hope that the problem has been resolved. I have made correction on my renewal application; please make changes on your records, to avoid future problems.

Thank you for you time and consideration, as it is very important for me to do things correctly, so that I may continue to help/assist our immigrant population, which so desperately need it.
