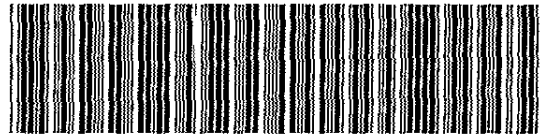


Article VIII:
