IN COMPLIANCE WITH CHAPTER 617, F.S., (NOT FOR PROFIT)**

ARTICLE I NAME

THE NAME OF THE CORPORATION SHALL BE:

ARTICLE III PURPOSE

THE PURPOSE FOR WHICH THE CORPORATION IS ORGANIZED IS:

THE SPECIFIC AND PRIMARY PURPOSES FOR WHICH THIS CORPORATION IS FORMED ARE:
TO PROVIDE AN OUTREACH PROGRAM FOR YOUTH IN THE COMMUNITY INCLUDING MENTORING,
TUTORIAL
AND AFTER-CARE SERVICES FOR LATCH-KEY CHILDREN;
TO PROVIDE AN ELDERLY SERVICES OUTREACH PROGRAM;
TO PROVIDE DRUG AND HIV/AIDS AWARENESS TRAINING AND ASSISTANCE;
TO OPERATE EXCLUSIVELY IN ANY OTHER MANNER FOR SUCH RELIGIOUS, CHARITABLE AND
EDUCATIONAL PURPOSES AS WILL QUALIFY IT AS AN EXEMPT ORGANIZATION UNDER SECTION 501(c)
(3) OF THE INTERNAL REVENUE CODE OF 1954.

ARTICLE IV

THE MANNER IN WHICH THE DIRECTORS ARE ELECTED OR APPOINTED:

THIS CORPORATION SHALL BE AUTHORIZED TO ISSUE MEMBERSHIP CERTIFICATES AS MAY BE
DETERMINED IN ITS BYLAWS.

THE POWERS OF THIS CORPORATION SHALL BE EXERCISED, ITS PROPERTIES CONTROLLED, AND ITS
AFFAIRS CONDUCTED BY A BOARD OF DIRECTORS, CONSISTING OF NOT LESS THAN THREE (3)
PERSONS. THE NUMBER OF DIRECTORS OF THE CORPORATION THREE (3), PROVIDED HOWEVER,
THAT SUCH NUMBER MAY BE CHANGED BY A BY-LAW ADOPTED BY THE MEMBERS. THE DIRECTORS
NAMED HEREIN AS THE FIRST BOARD OF DIRECTORS SHALL HOLD OFFICE UNTIL THE FIRST MEETING
OF MEMBERS AT WHICH TIME AN ELECTION OF DIRECTORS SHALL BE HELD. DIRECTORS ELECTED AT
THE FIRST ANNUAL MEETING, AND AT ALL TIMES THEREAFTER SHALL SERVE FOR A TERM OF ONE (1)
YEAR UNTIL THE ANNUAL MEETING OF MEMBERS.
