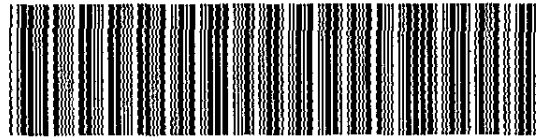





Article I NAME

The name of the corporation shall be: Filipino-American Republican Council of Florida, Inc.

Article II PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation shall be:
6077 Strickland Place, Pensacola, Florida 32506

Article III PURPOSE

The purpose for which the corporation is organized is:

To organize and represent American Citizens who are registered Republican voters, particularly those of Filipino descent or heritage; to insure the rightful participation of all American citizens, including those of Filipino descent or heritage, in the American political process; to uphold the cause of good government, the principles of the Republican Party and help elect Republican candidates to all levels of office; to recruit members and encourage members' participation in the activities and the advancement of the Republican Party and recognized Republican organizations at all levels; to address issues of interest to Republicans of Filipino, Asian, and Pacific Islander descent or heritage; to promote and encourage members' participation in the Florida Republican Party; to develop able and qualified Filipino-American Republicans to seek appointive and elected offices at all levels of government; to strive for responsible leadership through strategic planning, effective communication practices, the solicitation and expenditure of funds and other appropriate means in the interest of furthering the objectives of the Filipino American Republican Council of Florida.

Article IV. MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Directors and officers are elected at a general membership meeting. Elections are held every two years. Terms of office are from January through December of the subsequent second year. The right to vote and the right to serve as an officer or member of the Board of Directors is restricted to members whose dues are paid in full. Additional Members of the Board/Officers may be appointed by the President and approved by the current Board of Directors.
