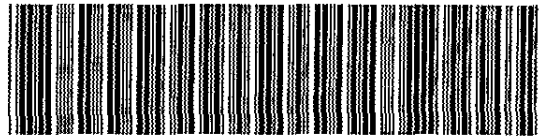

ARTICLES OF INCORPORATION
OF
A FLORIDA NON-PROFIT CORPORATION

ARTICLE I. NAME

The name of this corporation is THE DIVINE TRANQUILITY HOUSE INC.

ARTICLE II. PRINCIPAL PLACE OF BUSINESS

This is a non-profit organization organized solely for general charitable purposes pursuant to the Florida Not For Profit Corporation Act, located at 2494 Shiprock Ct. Deltona, Florida.

ARTICLE III. PURPOSES

The primary goal for which this corporation is formed is to provide decent affordable transitional housing in a secure drug and alcohol-free environment to assist at risk individuals to better their lives through counseling and educational programs. The Divine Tranquility House believes that through comprehensive education of chemical dependency and domestic violence will reduce incarceration, repeat offenders, and other criminal acts in our society.

ARTICLE IV. ELECTION OF DIRECTORS

The corporation shall have (5) initial board of directors, and shall not have less than three (3). The number of directors can be increased or decreased by the bylaws of the corporation. There shall be four directors constituting the initial board. Directors shall be elected by a majority of the initial board. The elections shall be conducted at such place, time, and date as designated by the board of directors by resolution.

ARTICLE V. REGISTERED OFFICE AND REGISTERED AGENT


