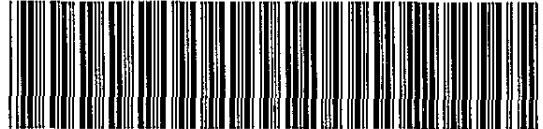

# ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation, not-for-profit, under Chapter 617 of the Florida Statutes, hereby adopts the following Articles of Incorporation.

## ARTICLE ONE NAME

The name of this corporation is:

## ARTICLE TWO DURATION

The duration of this corporation is perpetual.

## ARTICLE THREE ENABLING LAW

This corporation is organized pursuant to the Corporation Not-For-Profit law of the State of Florida set forth in Chapter 617 of the Florida Statutes.

## ARTICLE FOUR PURPOSES

The general purposes for which this corporation is formed are: To promote the democratic ideals in this hemisphere, specially in Cuba; to work against the violation of human and civil rights in this hemisphere, specially in Cuba; to promote political and individual freedom in this hemisphere, specially in Cuba; to help the individuals and institutions dedicated to attain the above mentioned rights in this hemisphere, specially in Cuba.

ARTICLE FIVE  
MEMBERSHIP

The authorized number, qualifications and manner of admission of members of this corporation, voting and other rights and privileges of members, the liability of members for dues and the method of collection thereof and the termination of membership shall be as set forth in the bylaws of this corporation.

ARTICLE SIX  
SHARES

This non-profit corporation will not issue any kind of shares.

ARTICLE SEVEN

#### ARTICLE NINE BYLAWS

Bylaws will be hereinafter adopted at the first meeting of the Board of Directors. Such bylaws may be amended or repealed, in whole or in part, by the members in the manner provided therein. Any amendments to the bylaws shall be binding on all members of the corporation.

#### ARTICLE TEN AMENDMENT OF ARTICLES

Amendments to these Articles of Incorporation may be proposed by a resolution adopted by the Board of Directors and presented to a quorum of members for their vote. Amendments may be adopted by the vote of, at least, two thirds of a quorum of members of the corporation.

#### ARTICLE ELEVEN DISSOLUTION

In the event of dissolution, the residual assets (money or any kind of goods) belonging to the corporation will be turned over to one or more organizations which themselves are non-profit as described in section 501 C 3 and 170 C 2 of the Internal Revenue Code and that its purposes are similar to the ones of this corporation.
