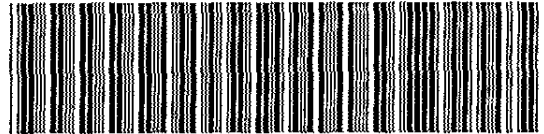

ARTICLES OF INCORPORATION
in accordance with Chapter 617 F.S. (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be Lauderdale-By-The-Sea Sister Cities Association, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be the Town Hall, 4501 Ocean Drive, Lauderdale-By-The-Sea Florida 33308.

ARTICLE III PURPOSE

The purposes of this corporation are educational, cultural, social, economic, and charitable. It will promote the best interests of residents of the Town of Lauderdale-By-The-Sea. Its activities will include establishing people-to-people links with towns and cities in other countries and organizing functions whereby residents of Lauderdale-By-The-Sea and its sister cities will gain better mutual understanding. Such activities will not be for personal gain and shall be NOT FOR PROFIT for purposes that qualify for exemption from Federal income tax.

ARTICLE IV MANNER OF ELECTION

One director will be appointed by the Town of Lauderdale-By-The-Sea. The other first directors will be appointed by the Town to serve until the first Annual Meeting of the Association, at which meeting directors will be elected by the members. Directors will be elected from among Association members in good standing. The Board of Directors shall elect from its numbers a chairman and other officers and may elect an Honorary President who shall be ex officio a member of the Board.
