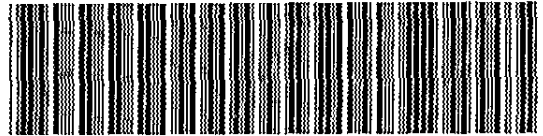

**ARTICLES OF INCORPORATION
OF
PINECREST CULTURAL COUNCIL CORP.**

The undersigned, desiring to form a non-profit corporation pursuant to Chapter 617 of the Florida Statutes, hereby adopts the following articles of incorporation.

**ARTICLE I
CORPORATE NAME**

The name of this non-profit corporation shall be Pinecrest Cultural Council Corp.

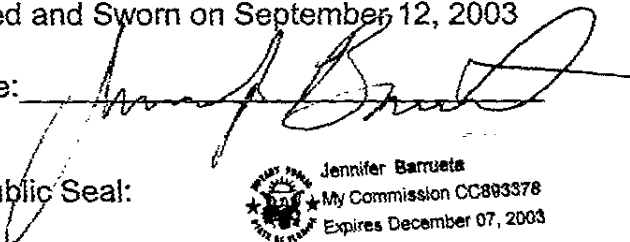
