

## ARTICLES OF INCORPORATION OF PINECREST CULTURAL COUNCIL CORP.

The undersigned, desiring to form a non-profit corporation pursuant to Chapter 617 of the Florida Statutes, hereby adopts the following articles of incorporation.

#### ARTICLE I CORPORATE NAME
