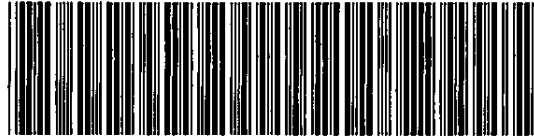



A Florida Nonprofit Incorporation**

The Undersigned, majorities of whom are citizens of the United States, desiring
to form a Non-Profit Public Benefit Corporation under the Non-Profit
Corporation Public Benefit Laws of the State of Florida,
do hereby certify:

**ARTICLE I - Name of Corporation: WOMEN CHOSEN FOR THE
PURPOSE OF GOD OUTREACH MINISTRIES, INC.**

The name of the Corporation shall be as follows: **WOMEN CHOSEN
FOR THE PURPOSE OF GOD OUTREACH MINISTRIES, INC.**

ARTICLE II - Location of Principal Office

The place in this state where the principal office of the Incorporation shall
be located 615 North "W" Street, Suite 2, Pensacola, Escambia County,
Florida 32505.

ARTICLE III – Purpose

This Corporation, **WOMEN CHOSEN FOR THE PURPOSE OF GOD
OUTREACH MINISTRIES, INC.**, is a Non-Profit Public Benefit and is
not organized for the private gain of any person. The Corporation is
organized under the Non-Profit Public Benefit Corporation Law, which is
organized exclusively for Charitable, Religious, and Educational Purposes.
The primary purpose of Women Chosen for the Purpose of God Outreach
Ministries, Inc. is to operate as a Public Benefit and shall proclaim the
Faith and the Lordship of Jesus Christ.

Our mission is to support and assist Women, Teenage Mothers, Battered Women and Battered Women with Children, Spiritually, Mentally, Physically, Financially through education and counseling through the various programs: Education Assistance - Tutoring, GED Classes, Mentoring, Parenting Skills, Substance Abuse Programs, Intervention and Prevention Programs, Employment Assistant: Resume Writing, Interviewing Techniques, Assisting in Job Placement, Housing Assistance- Assisting Residents with Utilities and Rental Programs, Homeless to Homeownership Programs, Low to Low Income Housing Assistant Programs-Affordable Housing, including but not limited to Youth-At-Risks Programs, Child Care Center, Ex-offenders Reintegration Programs, Elderly Assistance Programs, and to provide a Radio Ministry to the public.

This is a non-profit public organization which abides by the rules set forth as an exempt Corporation under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. This Corporation will have the powers as may be stated in its Articles of Incorporation, and such powers as are adopted or may be granted hereafter by law.

The Women Chosen for the Purpose of God Outreach Ministries, Inc. concept is keeping with the Faith Based Initiative Programs as proposed by President George W. Bush. This is a tremendous opportunity for this Outreach Ministry to serve the Social-Economic depressed area of Escambia County and Santa Rosa County Florida especially for economic development areas in our communities. Our objective is to have a positive affect within these communities by assisting to make available the various services and programs to each participant to enhance their ability to become productivity and self-sufficient citizens in their own community.

WOMEN CHOSEN FOR THE PURPOSE OF GOD OUTREACH MINISTRIES, INC., areas of interest are including, but are not limited to, the following;

Land and Building Acquisitions

Land and Building Acquisitions to be include, but is not limited to low-cost Affordable Housing for the Low Income to Low to Moderate Income Individuals for Affordable Housing, Land, Building and Structures for the

varies Programs if the need for such acquisitions are required, for the implementation of these Programs by this Corporation.

A. To expand opportunities available to said residents and groups to obtain adequate, low-cost housing accommodations by constructing, rehabilitating, and providing decent, safe and sanitary housing and/or facilities for persons and families of very low income, low-income to moderate income who otherwise would not be able to find or afford a suitable place to live. It is the purpose of the Corporation thereby to relieve the poor, distressed, underprivileged and indigent by enabling them to secure the basic human needs of decent shelter and to this lessen the burden of government and promote the social welfare. To provide such housing through land acquisition, production of affordable housing, rehabilitation of existing substandard building and construction of new facilities in the place of blighted structures or blighted vacant sites for the purpose of combating the deterioration of the community and contributing to it's physical improvement and other programs to aid those in need including for such purposes, the making of distribution to organizations that qualify as exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV - Duration of Corporation

The term of existence of this Corporation is perpetual.

ARTICLE V – Classes of Members

The Corporation shall have no members.

ARTICLE VI – Registered Office and Agent

The address of the initial Register Office of the Corporation is located at 2605 North 7th Avenue, Pensacola, Escambia County, Florida 32503. The name of the initial Register Agent of the Corporation is Victoria W. Lindsey. I, Victoria W. Lindsey, hereby accept the responsibility of being

the Registered Agent of Records for Women Chosen for the Purpose of God Outreach Ministries, Inc., 615 NORTH "W" STREET, Pensacola, Escambia County, Florida 32503.

ARTICLE VII – Election of Board of Directors

The Initial Board of Directors shall consist of at least Five (5) and not more than seven (7) members of the Board of Directors. The existing Board of Directors shall elect or appoint any members of this Board by a two-third major vote, and The Board of Directors shall appoint any and all Directors.

ARTICLE VIII – Change in Number of Board of Directors

A change in the number of Board of Directors of the Corporation shall be made only by Amendment to these Articles of Incorporation.

ARTICLE X - No Benefit to Private Persons or Political Activity

No part of the net earnings of the Corporation shall inure to the benefit of, or be attributable to its members, trustees, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. "Notwithstanding any other provision of these Articles, this Corporation shall not, except to an insubstantial degree engage in an activities or exercise any powers that are not in furtherance of the purposes of the Corporation or by a Corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code."

ARTICLE XI – Internal Affairs

The Internal Affairs of the Corporation shall be governed in accordance with the By-laws of this Corporation.


ARTICLE XII – Dissolution of Corporation






