ARTICLE ONE

Name

The name of the Corporation WOMEN CHOSEN FOR THE PURPOSE OF GOD OUTREACH

MINISTRIES, INC.

ARTICLE TWO

Principal Office and Address

The address of the principal office of the Corporation is 2605 N. 7th Avenue Pensacola, FL 32503 and the mailing address of the Corporation is 2605 North 7th Avenue Pensacola, FL 32503.

ARTICLE THREE

Duration

The term of existence of the Corporation is perpetual.

ARTICLE FOUR

Purpose

The primary purpose for which the Corporation is to operate as a ministry and shall proclaim the faith and the lordship of Jesus Christ.

Generally, to support Battered Women and Children, Spiritual, Physically, and Financially, To have and exercise all rights and powers conferred on non-profit corporations under the laws of the State of Florida or which may hereafter be conferred, including the power to contract, rent, buy or sell personal or real property; provided, however that this Corporation shall not, except to and in substantial degree, engage in any activities or exercise any power that are not in furtherance of the primary purpose of this Corporation.

No part of the net earnings of this Corporation may inure to the benefit of any private shareholder or individual. No substantial part of the organization's activities may consist of lobbying, and the organization may not participate in any political campaign activities on behalf of a candidate for public office.

This Corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purpose, the making of Internal Revenue Code, or corresponding section of any future Federal tax code.

ARTICLE FIVE

Members

The Corporation shall not have members.

ARTICLE SIX

Election of Directors

There shall be at least four (4) Directors. The Directors are appointed.

ARTICLE SEVEN

Change in Number of Directors

A change in the number of Directors of the Corporation shall be made only by amendment to these Articles of Incorporation.

ARTICLE EIGHT

Registered Office and Agent

The address of the initial registered office of the Corporation is 2605 North 7th Avenue, Pensacola Florida, 32503. The name of the initial registered agent of the Corporation at such address is VICTORIA W. LINDSEY.

Upon the dissolution of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this Corporation shall be distributed for one or more exempt purpose within the meaning of Section 501 (c)(3) of the Internal Revenue Code or shall be distributed to the Federal Government, or to a state or to local government, for a public purpose.

ARTICLE TWELVE

No Political Activity

No substantial part of the activities of this Corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, except as otherwise provided by Section 501(h) of the Internal Revenue Code. This Corporation shall not participate in or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

ARTICLE THIRTEEN

No Benefit to Private Persons

No part of the net earnings of this Corporation shall inure to the benefit of or be distributed to its members, directors, officers, or other private persons, except that this Corporation shall be authorized. This Corporation is empowered to pay reasonable compensation for services rendered to make payment and distribution in furtherance of the purposes set forth in these Articles.

ARTICLE FOURTEEN

Limited to Section 501 (c)(3) Activity

Notwithstanding any other provisions of these Articles, this Corporation shall not carry on any other activities not permitted to be carried on (1) by a Corporation exempt from
Federal Income Tax under Section 501 (c)(3) of the Internal Revenue Code or (2) by a
Corporation contributions to which are deductible under Section 170 (c)(2) of the Internal
Revenue Code.


