## Articles of Incorporation

In compliance with Chapter 617, F.S. (Not for Profit)

### Article I: Name

The name of this corporation shall be: Foundations for Life, Inc.

### Article II: Principal Office

The principal place of business and mailing address of this corporation shall be: 3110 Brookridge Dr. Tallahassee, FL 32305

### Article III: Purpose

The purpose for which this corporation is organized is to develop and manage affordable housing for people of low and moderate income. To this end the corporation shall at all times be operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the internal revenue code, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

### Article IV Manner of Election

The manner in which the directors are elected or appointed is by a majority vote of the current officers.

### Article V Initial Directors

Co-Directors: Alphonso Y. Craig and Johnny L. Craig, II

### Article VI Initial Registered Agent and Street Address

Alphonso Craig of 3110 Brookridge Dr. is the registered agent for Foundation for Life, Inc.

### Article VII Incorporator


