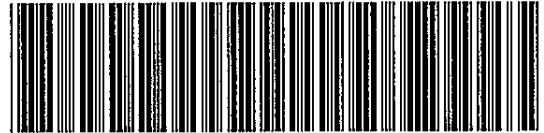

## ARTICLES OF INCORPORATION OF

- ONE: The name address of this principal corporation is Clarence Jenkins Ministries, Inc. at 6331 NW 32<sup>nd</sup> Street Gainesville, Fl. 32605. The corporation is organized pursuant to the Florida Nonprofit Code.
- TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to: Child Care, Job Training, Job Placement, Land Acquisition Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Tutoring, AIDS, Elderly Care and other programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

  - (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal Income tax under Section 501 (c)(3) of the Internal Revenue Code Or (2) by a corporation contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code.
  - (c) No substantial part of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing of distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.


