ARTICLES OF INCORPORATION OF ABUNDANT LIFE CHRISTAIN CENTER CHURCH OF CHRIST

DISCIPLES, INC

A Non-profit Corporation

We, the undersigned, hereby, associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida applicable to corporation not for profit, and respectfully petition the Secretary of the State for approval of such incorporation under the following proposed Articles of Incorporation:

ARTICLE I

The name of this corporation shall be Abundant life Christian Centre Church of Christ Disciples, Inc of Melbourne, Florida, and its principal place of business shall be at 820 Avalon St., Se Palm Bay, Florida, County of Brevard and State of Florida.

ARTICLE II ENABLING LAW

This corporation is organized pursuant to the Corporations Not For Profit Law of the State of Florida, set forth in Part One of Chapter 617 of the Florida Statues.

ARTICLE III PURPOSES

The general nature and purpose of this corporation shall be to make a personal impact in the heart, mind and spiritual needs of the family through personal interaction, with parents and youth through Jesus Christ our Savior.

This corporation is organized exclusively for charitable, educational, religious, or scientific purpose within the meaning of Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax codes).

This corporation is organized and operated exclusively for non-profit purposes, and no part of any net earnings shall inure to the benefits of any member, director, or officer.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for service s rendered and to make payments and distributions in furtherance of Section 501©(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of proganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in

(including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income tax under 501(c)(3) of the Internal Revenue code (or corresponding section of any future Federal tax code) or (b) by a corporation, contributions to which are deductible under Section 170 (c)(2) of the internal Revenue Code (or corresponding section of any future Federal tax code).

ARTICLE IV

TERM

The corporation shall have a perpetual existence.

ARTICLE V

MEMBERSHIP

Members shall quality by agreeing to the purpose as set forth in Article III and shall be admitted into membership according to the By-laws. The class of members and all voting rights and other rights, interests, and privileges of each member shall be set forth in the bylaws. (See By-laws Articles V.)

ATRICLE VI

MANAGEMENT OF CORPORATE AFFAIRS

(A) BOARD OF DIRECTORS. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of not less than (3) three not more than (15) fifteen Directors. (See Bylaws Article VI)
