ARTICLES OF INCORPORATION

ARTICLE THREE

The purpose or purposes for which the corporation is organized is (are):

This corporation is organized exclusively for one or more of the purpose as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. This corporation will not attempt to influence legislation as a substantial part of its activities and will not participate at all in campaign for or against political candidates. In addition, none of the earnings of the corporation will inure to any private shareholder or individual, except for reasonable compensation for services rendered. Further, our purpose is to establish a biblical foundation with the community through various programs and activities.

If the corporation dissolves, its assets must be distributed for an exempt purpose within the meaning of Section 501(c)(3).
