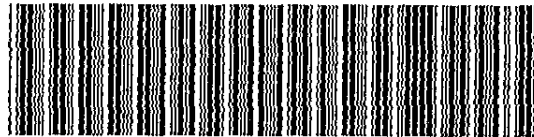



**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the corporation is Glendale Presbyterian Church, Inc.

**ARTICLE II - DURATION**

The corporation shall exist perpetually.

**ARTICLE III - PRINCIPAL OFFICE AND MAILING ADDRESS**

The address of the principal office of the corporation shall be 9218 State Hwy. 83 North, DeFuniak Springs, Florida 32433, and the mailing address of the corporation shall be 9218 State Hwy. 83 North, DeFuniak Springs, Florida 32433.

**ARTICLE IV - PURPOSES OF THE CORPORATION**

The purposes of the corporation are to promote and proclaim the Gospel of Jesus and the Christian religion in all lawful manners, to provide for public worship and Christian instruction, to provide Christian education for all ages and grades, to minister to the spiritual, social and temporal needs of individuals, to provide a continuing public witness for Christian liberty and morality and to disseminate information by all available media and to foster and encourage Christian living in the community, nation and world.

**ARTICLE V - MEMBERSHIP**

The first members of the corporation shall be the present members of Glendale

Presbyterian Church, an unincorporated association. The condition and terms of and the qualification for membership in the corporation shall be provided for in the By-Laws, and additional members shall be elected as provided for in the By-Laws.

ARTICLE VI - INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The initial registered office shall be at 664 Baldwin Avenue, DeFuniak Springs, Florida 32435, and the initial registered agent shall be William H. Green.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

#### ARTICLE IX - DISTRIBUTIONS ON LIQUIDATION OR DISSOLUTION

In the event of the dissolution of this corporation at any time or for any reason, all of the assets of the corporation shall be given or contributed to Glendale Presbyterian Church Cemetery Association Inc., or its successor, if in existence, and if not, to one or more other corporations, associations, entities or institutions which are wholly of a public and

nonprofit nature, which are organized and operated exclusively for religious, charitable, scientific, or educational purposes, and which shall at that time qualify as an exempt organization or organizations under Sections 501(C)(3) and 170(C)(2) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue Law), and such contributions shall be made to such corporation, association, entity, and/or institution as may be determined by the Directors.

#### ARTICLE X - BY-LAWS

The By-Laws of the corporation shall be the applicable provisions of the Book of Order of the Evangelical Presbyterian Church, and such other By-Laws adopted from time to time.
