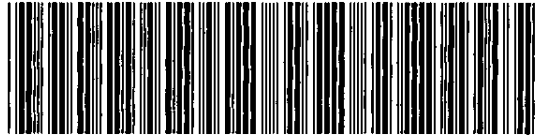

Pursuant to the provisions of sections 617.01011 through 617.2103, Florida Statutes, and Article I of the Articles of Incorporation of Collier County Housing Development Corporation, (the "Corporation"), the undersigned, being an authorized director of the Corporation, does hereby act on behalf of the Corporation in adopting and filing these Articles of Amendment to the Corporation's Articles of Incorporation.

The Corporation's Articles of Incorporation shall be amended as follows:

ARTICLE I – NAME

The name of the Corporation shall be Housing Development Corporation of SW Florida, Inc.

This amendment was adopted on the 9th day of October 2008, by at least two-thirds (2/3) of the number of the Board of Directors of the Corporation, and the undersigned director was authorized to file these Articles of Amendment to the Articles of Incorporation of the Company with the Florida Department of State.
