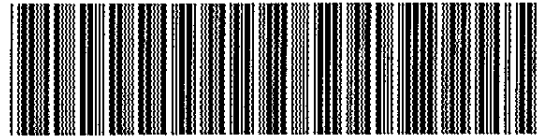

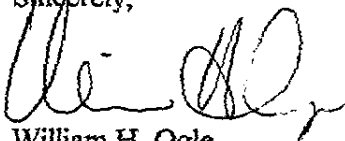

The undersigned subscriber of these Articles of Incorporation, a natural person competent to contract, hereby forms a non profit, educational, religious corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is:

ASSOCIATION OF THE HOLY NAME, INC. d/b/a AOHM, Inc.

ARTICLE II. PURPOSE OF THE CORPORATION

The purpose of the corporation is to provide association for persons on the spiritual path of the Holy Name, to educate other persons on the benefits of that path and to do all things related to the above purposes which are consistent with and not in violation of § 501 (C)(3) of the Internal Revenue Code of the United States of America and of any amendments or court interpretations thereof and to perform any other lawful activities consistent with the laws of the State of Florida as they relate to not for profit, religious and educational corporations and all other lawful activities consistent with and not prohibited by the above referenced provisions of the Internal Revenue Code of the United States of America.

ARTICLE III. ELECTION OF DIRECTORS

The initial Board of Directors is created by this incorporation. Directors may be added or subtracted by a majority vote of the Directors.

ARTICLE IV. MEMBERSHIP

Membership in the corporation shall be by invitation with approval by the Board of Directors.
