We, whose names are signed hereto, do hereby associate ourselves together for the purpose of forming a body corporate, not for profit, under the laws of the State of Florida, and under the following charter:

# **ARTICLE I**

#### NAME

The name of this corporation is First Baptist Church of Bascom, Florida, INC.

# **ARTICLE II**

#### **TERM OF EXISTENCE**

This corporation is to exist perpetually; and the corporate existence will commence on the filing of these Articles of Incorporation by the Florida Department of State.

#### ARTICLE III

#### **PURPOSE**

The purpose for which this corporation is organized shall be religious; its more specific purposes being the up building of the Kingdom of Christ, in the Town of Bascom, in the State and throughout the world; to promote spiritual religion by all spiritual means; to foster the spirit of missions, state and world-wide; to support Christian and theological education; to encourage the spirit and practice of liberal and systematic giving; to purchase, own, sell, mortgage and lease real estate and personal property for the purpose

hereinafter set forth; and generally to have all the powers incident to corporations of this character.

# **ARTICLE IX**

#### **OFFICERS**

The officers of this corporation shall consist of a President, one Vice President, a Moderator, and a Secretary/Treasurer. These officers, except for the Moderator, shall be elected annually by a majority vote of the quorum (as designated below) of the First Baptist Church of Bascom, Florida, the incorporated body, present and voting at the regular annual business meeting of the members of said Church to be held on the second (2<sup>nd</sup>) Wednesday in January of each year, or at any special meeting called for that purpose. Any vacancies in the Board of Directors occurring during the year may be filled by a majority vote of the members of the quorum of the First Baptist Church of Bascom, Florida, the incorporated body, present and voting at any regular or special meeting. church shall have such other officers for the government and conduct of its affairs as may be provided by the By-Laws of the said Church. No less than fifteen (15) members shall constitute a quorum to transact any business at any regular or special meeting of the members of said church, if such business is of a legal nature. Not less than ten (10) members shall constitute a quorum to transact business of a nature other than legal. The pastor of the First Baptist Church of Bascom, Florida shall be Moderator, and the meetings may be presided over by either the Chairman of the Deacons or the Moderator. The affairs of this corporation shall be managed by Billy James, President, Bryant Southwell, VicePresident, and Doug Bryan, Secretary/Treasurer, until the first election of officers under this Charter.

# ARTICLE X

#### **BY-LAWS**

The By-Laws of this corporation may be made, altered and rescinded by a majority vote of the members of the corporation present at any regular or special meeting, due notice of which has been sent to all of the members, in accordance with the By-Laws or has been given from the pulpit of the church on two successive regular meetings.


