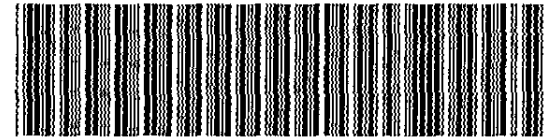

The undersigned incorporator, for the purpose of forming a corporation imder the Florida Nor for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be Youth Reachers of Baker County Inc.

ARTICLE II PRINCIPLE OFFICE
