The undersigned, for the purpose of forming a corporation not for profit under the provisions of Chapter 617 of the Florida Statutes, hereinafter referred to as the Corporation, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be the LATIN AMERICAN MEDICAL ASSOCIATION OF MANATEE AND SARASOTA, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal office and the mailing address of the Corporation shall be 812 86th Street Court N.W., Bradenton, Florida 34209.

ARTICLE III - PURPOSE AND POWERS

The purpose for which the Corporation is formed is to foster and promote comradery and fellowship among individuals of Latin American descent who practice or are otherwise involved in the field of medicine; to provide a network for individuals with common ethnic and professional backgrounds; to provide a means of social interaction and educational opportunities and to promote the culture of the members.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is provided for in the Bylaws of this corporation.

ARTICLE V - TERM OF EXISTENCE

The corporation shall have perpetual existence.

ARTICLE VI - BOARD OF DIRECTORS

A. The business and affairs of the Corporation shall be managed by a Board of Directors, the members of which shall be hereinafter referred to as Directors.
