A. <u>Purpose and Powers of the Association:</u> The Association shall operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent with the Florida Department of Environmental Protection permit No. 16-2398000-002-EM requirements and applicable District rules, and shall assist in the enforcement of the Declaration of Covenants and Restrictions which relate to the surface water or stormwater management system.

The association shall levy and collect adequate assessments against members of the Association for the costs and maintenance and operation of the surface water or stormwater management system.

B. <u>Dissolution</u>. In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an entity which would comply with Section 40C-42.027, F.A.C., and be approved by the Florida Department of Environmental Protection prior to such termination, dissolution or liquidation [40C-42.027(4)(a), (b); 40C-42.900; 40C-4.301(1)(j), F.A.C.
