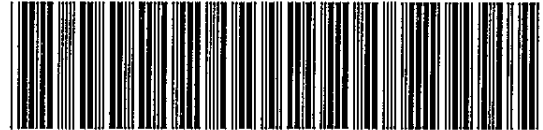

*Articles of Incorporation  
Of  
Iglesia "La Gran Comisi3n " Inc.  
(The Great Commission Church Inc. - English)*

The undersigned, acting as the incorporators of a corporation pursuant to Chapter 617 of the Florida Statutes, the Florida Not For Profit Corporation Act, adopt the following Articles of Incorporation for such corporation:

*Article 1*

The name of the corporation is **IGLESIA "LA GRAN COMMISSION" INC.**  
(Which means, The "Great Commission Church" Inc. In English)

*Article 2*

The principal place of business address of this corporation is 4100 Rainbow Dr. Fort Myers, Florida 33916 and the mailing address of this corporation is P. O. Box 50578 Fort Myers, Florida 33994-0578, in Lee County.

*Article 3*

- A. The corporation is organized exclusively for religious, charitable, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law), including, but not limited to, for such purposes, the establishing and maintaining of religious worship, the building, maintaining and operating of churches, parsonages, schools, chapels, radio stations, television stations, rescue missions, seminars, crusades, concerts, print shops, daycare centers, camps, and nursing homes.
- B. The corporation will ordain and license men and woman to the Gospel Ministry; evangelize the unsaved by the proclaiming of the Gospel of the Lord Jesus Christ, educate Believers in a manner consistent with the requirements of Holy Scripture both in churches and in schools of Christian education, maintain missionary activities in The United States and any foreign country, and any other lawful purpose or Purposes not for pecuniary profit and not specifically prohibited to nonprofit corporations under the laws of the state of Florida.

#### *Article 4*

The number of directors of the corporation will be determined by resolution of the directors entitled to vote but shall not be less than Three (3) directors. The method, Of election of directors shall be set forth in the Constitution & Bylaws of the corporation.

#### *Article 5*

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and To make payments and distributions in furtherance of the tax-exempt purposes of the corporation set forth in Article 3.

#### *Article 6*

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, distribute all of the assets of The corporation to such organization or organizations organized and operated exclusively for charitable, religious, or educational purposes as shall at the time qualify as an organization exempt from Federal income taxation under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) as the Board of Directors shall determine.

#### *Article 7*

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

#### *Article 8*

The corporation shall have a racially nondiscriminatory policy and therefore shall not discriminate on the basis of race, color, or national or ethnic origin.

#### *Article 9*

The street address of the initial registered office of the corporation is, 3728 Estelle Avenue, Fort Myers, Florida, 33916, and the name of the initial registered agent of the corporation at the initial registered office is Emerson O. De Leon Garcia.

## *Article 11*

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, except that the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

## *Article 12*

The period of the duration of the corporation is perpetual unless dissolved according to Law.

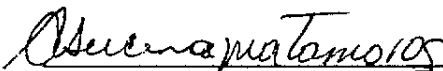
