## ARTICLES OF DISSOLUTION AND PLAN FOR DISTRIBUTION OF ASSETS SANS SOUCI BASEBALL FOUNDATION, INC.,

WHEREAS, The undersigned three (3) persons, being all of the directors of Sans Souci Baseball Foundation, Inc., a non-profit Florida corporation ("Corporation"), acting pursuant to the Corporation's By-Laws and Chapter 617, Florida Statutes, and by consent of all members of the Board of Directors on October 22, 2019, hereby find as follows:

- A. The Corporation is a Florida non-profit corporation, which filed its Articles of Incorporation with the Department of State, State of Florida, on or about September 24, 2003, Document No. N03000008354;
- B. The Corporation is a tax-exempt organization within the meaning of Section 501(c)(3) of the Internal Revenue Code;
  - C. The Corporation does not have members entitled to vote;
- D. The Corporation was administratively dissolved by the State of Florida on September 23, 2016;
  - E. The Corporation has been inactive since September 23, 2016;
- F. The Corporation has not received any contributions or donations since September 23, 2016;
- G. The Corporation's only assets are funds in its Account No. 0038980525, with Regions Bank, ("Bank Account"), in the amount of \$2,775.55 ("Funds");
- H. The Corporation's only creditor is Bledsoe, Schmidt & Wilkinson, P.A., to which it owes \$152.50 ("Creditor");
  - 1. The purposes for which the Corporation was formed are no longer capable

of being attained and the Corporation should be voluntarily dissolved;

- J. The Corporation wishes to distribute its assets for an exempt purpose within the meaning of Section 501(c)(3) of the Internal Revenue Code to a corporation engaged in activities substantially similar to those of the Corporation; and
- K. The Jacksonville Rugby Football Club, Inc., is a Florida non-profit corporation and a tax-exempt organization within the meaning of Section 501(c)(3) of the Internal Revenue Code, and is engaged in activities substantially similar to those of the Corporation.

Accordingly, in consideration of the foregoing premises, by written consent of all members of the Board of Directors of Sans Souci Baseball Foundation, Inc., and upon unanimous approval of all directors, it is

#### **HEREBY RESOLVED:**

- 1. From its Funds, the Corporation shall pay the Creditor \$152.50 which constitutes payment of the full amount owed:
- 2. After payment of its Creditor, the Corporation shall distribute the remaining Funds in the Bank Account to the Jacksonville Rugby Football Club, Inc., for deposit into the Jacksonville Rugby Football Club Building Fund account at 121 Financial Credit Union, Jacksonville, Florida, for the purposes of development of a youth rugby playing field.
  - The Corporation shall thereafter close the Bank Account.
- 4. The Corporation shall file its final income tax return with the U.S. Internal Revenue Service.
- 5. The Corporation shall notify the State of Florida, Department of State, that it has been voluntarily dissolved.

- 6. The effective date of the voluntary dissolution shall be November 30, 2019.
- 7. James A. Bledsoe, Jr., is authorized to act on behalf of the Corporation in taking such acts as may be necessary to perform the acts described in paragraphs 1 through 5 above and otherwise wind up the affairs of the Corporation.
