PURPOSE AND NATURE OF CORPORATION

Faith Global Vision, Inc., has been organized exclusively for religious purposes, and the activities are, and have been, the sending out through the mail, a monthly letter of encouragement to all recipients. These activities are geared toward bringing people to the knowledge of Christ, and encouraging those who are already Christians. This will continue indefinitely, and as opportunity arises, I will be preaching and teaching the "Word of God" in churches or other establishments made available, across the United States.

It will be supported by "freewill donations", hopefully covering all expenses. There are no grants or other means of support, except my personal Social Security income. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to it's members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of the Articles, the corporation shall not carry

on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code) or b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)


I am the founder of this organization, and the person writing these letters, and I make no financial demands on anyone, or charge a specific amount for my services. The only requirement from anyone would be, if I were invited to minister for a church, they would need to supply the church or auditorium and pay such expenses.

The time and effort required for each letter, preparing them for mailing, takes approximately one full week for typing, copying, and shipping by bulk mail.

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for public purpose.
