

ARTICLES OF INCORPORATION

NEW BEGINNING COMMUNITY RESIDENTIAL HOME, INC.

The undersigned Incorporators, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes and to comply with Section 501(C)(3) of the Internal Revenue Code of 1986, as amended, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation shall be NEW BEGINNING COMMUNITY RESIDENTIAL HOME, INC., a Not For Profit Corporation.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business for this corporation shall be 3712 McLean Avenue, Rockledge, FL 32955. The mailing address of this corporation shall be 3712 McLean Avenue, Rockledge, FL 32955.

ARTICLE III

PURPOSES

The general nature and purposes of this corporation are as follows:

To provide a second chance and a new beginning for individuals, including treatment, rehabilitation, and other related services as needed.

This corporation is organized and operated exclusively for non-profit purposes, and no part of any net earnings shall inure to the benefit of any member, director, or officer.

This corporation shall have and exercise all rights and powers conferred upon corporations under the laws of the State of Florida, provided, however, that this corporation is not empowered to engage in any activity that in itself is not in furtherance of its purposes.

ARTICLE IV

TERM

This corporation shall_have a perpetual_existence.

ARTICLE V

MEMBERSHIP

Members shall qualify by agreeing to the purposes as set forth in Article III, and shall be admitted into membership upon a unanimous vote of the Directors. There shall be one class of members only. All voting rights and other rights, interests, and privileges of each member shall be equal.

ARTICLE VI

MANAGEMENT OF CORPORATE AFFAIRS

(a) <u>BOARD OF DIRECTORS</u>. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of three Directors. The number of Directors herein provided for may be changed by a By-Law duly adopted by the members entitled to vote. Directors shall be elected annually by a majority vote of the membership.

ARTICLE IX

BY-LAWS

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for religious purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent federal tax laws.


