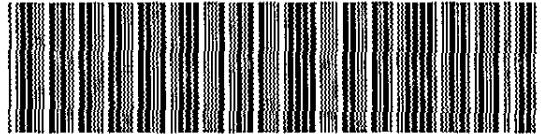

ARTICLE 1 - NAME

The name of the Corporation is: **Fresh Start Ministries International, Inc.**

The principle place of business and mailing address is: **c/o Calvin Chin
846 NW 200th Street, Miami, FL 33169**

ARTICLE 2 - PURPOSE/s

The corporation is organized and will be operated exclusively for religious, charitable and educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United State of Internal Revenue Law.

Specifically, the corporation is organized to cultivate, promote, and extend the teachings and practices of the Bible. To receive tithe, freewill offerings, gifts and bequests in order to promote the purposes of the corporation.

To exercise all rights and powers conferred by the laws of the State of Florida upon Non-Profit Corporations.

ARTICLE 3 - REGISTERED AGENT

ARTICLE 4 - DIRECTORS

The number of directors constituting the initial Board of Directors is **Seven [7]**, the number of directors may be increased or decreased by amendment of the Bylaws, but, shall in no case be less than four.

The initial Board of Directors were appointed by the President of the corporation, and will hold office until the first annual Board meeting, at which time they may be elected.

ARTICLE 5 - ORGANIZATION

A. This corporation is organized and operated exclusively for religious and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

B. Notwithstanding any other provision of these articles, this organization shall carry not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

C. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office.

ARTICLE 6 - CORPORATE ASSETS

Upon dissolution of the corporation, assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes, and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code.

ARTICLE 7 - MEMBERSHIP

The corporation may have one or more classes of members, the qualification and rights, including voting rights of which shall be described within the bylaws.

ARTICLE 8 - OFFICERS

The Officers of the corporation shall consist of a President, Vice President, Secretary and Treasurer. Each shall be elected by the Board of Directors, and may be removed by the Board at such time and in such manner as may be prescribed in the Bylaws.
