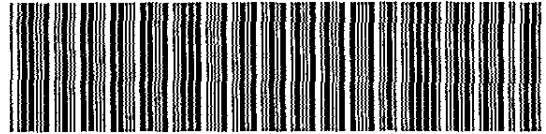

The purpose of CULINART FOUNDATION Inc. is to provide culturally competent nutritional services to South Florida's communities.


This purpose will be achieved through activities providing culturally relevant:
