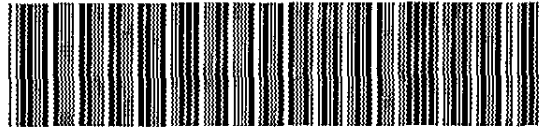

ARTICLE 1 - NAME

The name of the corporation is **MAHARSHI DAYANANDA GURUKULA INC**
(Ft Lauderdale Chapter) – “hereinafter Corporation”

ARTICLE 2 - PRINCIPAL OFFICE

The address of the principal office of this Corporation is 6161 SW 1st Street, Margate Florida 33068 and the mailing address is the same.

ARTICLE 3 - PURPOSE

The purposes of the Gurukula are as follows:

- A. To create a forum for (but not limited to) individuals in the Hindu community who will seek to maintain the cultural and religious heritage of their homelands. The Gurukula is committed to improving the physical, social and spiritual states of being of its members by creating and maintaining a number of educational, social and religious institutions that will respond to the emerging needs of the growing immigrant populations in the United States.
- B. To promote social, cultural and humanitarian activities
 - ✓ designed to address the problems that exist in our diversified communities, and
 - ✓ focused on the motto: *Lessening Human Suffering – Educating Human Minds.*
- C. To provide for the welfare of the Hindu and other communities in Ft Lauderdale, the United States of America, and even communities outside of the USA.
- D. To propagate the teachings of the four Vedas as interpreted by Maharshi Swami Dayananda Saraswati.

ARTICLE 4 - MANNER OF ELECTION

- A. The Gurukula Sabha at the first scheduled meeting shall elect the Executive Director. To ensure continuity for the goals and vision of the Gurukula, the first Executive Director, once elected, shall serve for life. The Gurukula Sabha shall determine the tenure of office of subsequent Executive Directors.

- B. The Board of Directors shall elect the following:
1. One Administrator
 2. One Recording Secretary
 3. One Treasurer
 4. Any number of Committees charged with specific operations. A Committee shall comprise any number of members and shall be coordinated by one registered, responsible member. All persons elected and appointed by the Board of Directors shall work in harmony with the Executive Director for a realization of the purposes of the Gurukula.
- C. All resolutions pertaining to the day-to-day affairs of the Gurukula, except motions on expulsion and dissolution, shall be passed by a simple majority of the Board of Directors. The Administrator shall forward these resolutions in writing to the Executive Director for review and approval. The Executive Director shall provide to the Board of Directors an explanation for any decision not approved.
