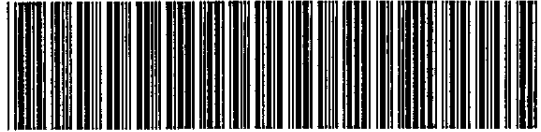

I am writing this letter to inform you that page 2 of this enclosure was accidentally omitted from the envelope that was submitted to this office this morning.


The amendment forms for M.S. Employment Group, Inc. were mailed out earlier today with a check for \$52.50 for filing fees. It also included the forms for revision.

Article III

Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the country in which the principal office of the organization is then located, exclusively for such purposes.
