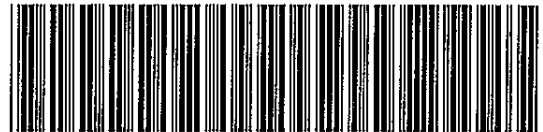

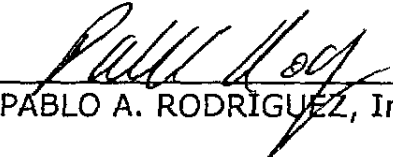
ARTICLE IX DUTIES
