# Articles of Amendment to Articles of Incorporation for

## THE CENTER FOR EDUCATIONAL AND LIFE COACHING, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment(s) to its Articles of Incorporation:

### Amendments Adopted:

Article III is amended by deleting the original, existing paragraph in its entirety and adding the following two paragraphs:

### Article III

The specific purpose for which this corporation is organized is to provide educational services that teach both academic and life skills to ensure the development of independent, competent, responsible and caring citizens. The Center is a non-stock, not-for-profit corporation organized exclusively for charitable and educational purposes under Internal Revenue Code Section 501(c)(3) or corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of any private individual. Notwithstanding any other provision of these Articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation. No substantial part of its activities will be carrying out propaganda or otherwise attempting to influence legislation. The corporation will not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
