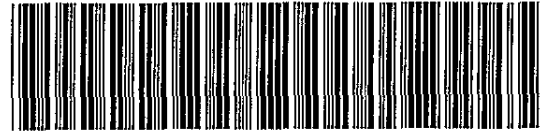

ARTICLES OF INCORPORATION
OF
ARTS4LIVING CORPORATION

Articles of incorporation of the Undersigned, a majority of whom are citizens of the United States, designing to form a Non-profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

ARTICLE I
Name

The name of the Non-profit Corporation is **ARTS4LIVING CORPORATION**.

ARTICLE II
PRINCIPAL OFFICE

The principal office of the Corporation is to be located in the city of Miami, Miami Dade County.

ARTICLE III
PURPOSE

ARTS4LIVING a Non-profit Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt and organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTS4LIVING is a Corporation with a mission to render a means of economical development through artistic awareness to people residing in culturally underserved communities through art education and representation.

The Corporation provides career oriented programs in the arts based on the cultural heritage of local ethnic minority youth, and adults. That encompasses a large population of ethnic minorities.

The purpose of **ARTS4LIVING** is to provide::

- An opportunity to practice decision making.
- Provide knowledge about the elements of fine arts and develop a rich vocabulary increase the ability to discuss them.
- Experiences in the arts provide opportunities for students to improve their self-esteem through learning about the subject matter.
- Learning the arts provides students with opportunities to develop a craft while exploring originality, creativity and analytical thinking.
- Learning the arts leads students to new ways of solving problems through unique challenges in the arts, both mental and physical.

Most of the potential students come from very low-income, mostly migrant families. For them, we will provide workshops free of costs or at affordable rates.

ARTICLE IV DESCRIPTION OF ACTIVITIES

- 1- Art workshops for low-income students who wish to develop artistic skills.
- 2- Intensive weekend workshops in the arts to local regional and national students using resident studio Artists and invited “Masters” in various media as teachers.
- 3- Hold art exhibitions, meetings and workshops within other outside cultural and community organizations.

ARTICLE V MANNER OF ELECTION

The directors named herein as the first Board of Directors shall hold office until the first meeting of the members at which time and election of Directors shall be held.

Directors elected at the first annual meeting, and at all times thereafter, shall serve for a term of one (1) year until the annual meeting of members following the election of Directors and until the qualification of the successors in office. Annual meeting shall be held on or about the 15th day of August each year at any place or places as the Board of Directors may designate.

**ARTICLE IX
EARNINGS AND ACTIVITIES**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contribution to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code

**ARTICLE X
DISTRIBUTION OF ASSETS**

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the corporation, dispose of all the assets of corporation exclusively for the purposes of the corporation in such a manner, or to such organization or organizations organized and operated exclusively for charitable, education, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1954, as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by court of competent jurisdiction in the County in which the principal office of the corporation is then located exclusively for such purposes or to such organization or organizations as such court shall determine, which are organized and operated exclusively for such purposes.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
