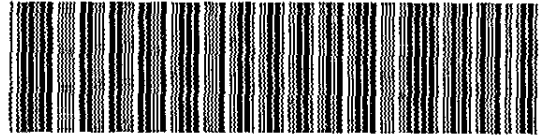

Attached is the Articles of Dissolution for Academie Chretienne Haitienne D'Orlando, Inc. filed on September 22, 2003.

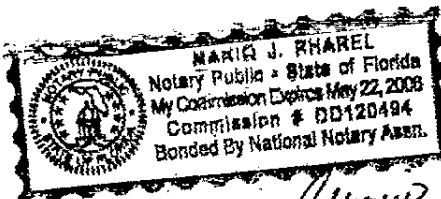
I have decided to dissolve the corporation and a motion was passed and adopted to dissolve the corporation as a for profit corporation.



**ARTICLES OF INCORPORATION  
FOR THE  
ACADEMIE CHRETIENNE HAITIENNE D'ORLANDO, INC**

**ARTICLE I  
NAME**

The name of the corporation shall be **ACADEMIE CHRETIENNE HAITIENNE D'ORLANDO, INC.**

**ARTICLE II  
REGISTERED OFFICE**

The principal place of business and the mailing address of the corporation are listed below:

**ARTICLE III  
PURPOSE**

This corporation is organized and operated exclusively to manage, operate, guide, direct and promote Acadamie Chretienne Haitienne D'Orlando, Inc., and to educate students, within the meaning of Internal Revenue Code Section 501(c)(3) of 1986. The corporation has a racially nondiscriminatory policy as to workers and students, and that it does not discriminate against applicants and students on the basis of race, color, or national or ethnic origin. Also, ACHDO admits the students of any race to all the rights, privileges, programs, and activities generally accorded or made available to students at the school and that the school does not discriminate on the basis of race in administering its educational policies, admission policies, scholarship and loan programs, and athletic and other school-administered programs. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

**ARTICLE IV  
LIMITATIONS**

At all times the following shall operate as conditions restricting the operations and activities of the corporation:

1) No part of the net earnings of the corporation shall inure to any member of the corporation not qualifying as exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, nor to any Director

or officer of the corporation, nor to any other private persons, excepting solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation;

2) No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office; and

3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.

The corporation shall not lend any of its assets to any officer or director of this corporation [unless such loan program is regularly conducted as part of the activities of the organization and the qualification of the individual to participate in same is determined by a panel comprised solely of non-Board members], or guarantee to any person the payment of a loan by an officer or director of this corporation.

#### **ARTICLES VI DIRECTORS**

The corporation has no members. The rights which would otherwise vest in the members vest in the directors of the corporation (hereinafter "Trustees") of Academie Chretienne Haitienne D'Orlando, Inc. (hereinafter "ACHDO"). Actions which would otherwise require approval by a majority of all members or approval by the members require only approval of a majority of all Trustees or approval by the Board of Trustees (hereinafter "Board"). The management and affairs of the corporation shall be at all times under the direction of the Trustees, whose operations in governing the corporation shall be defined by statute and by the corporation's by-laws. No Trustee shall have any right, title, or interest in or to any property of the corporation.

**ARTICLE VII  
DEBT OBLIGATIONS AND PERSONAL LIABILITY**

No officer or Trustee of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers or Trustees be subject to the payment of the debts or obligations of this corporation.

**ARTICLE VIII  
DISSOLUTION**

The property of this corporation is irrevocably dedicated to the management, operation, guidance, direction and promotion of Academie Chretienne Haitienne D'Orlando, Inc., and the education of students, and no part of the net income or assets of the organization shall ever inure to the benefit of any director, trustee, officer or member thereof to the benefit of any private person.

In the event of the dissolution of the corporation for any reason, any assets of the corporation remaining after compliance with applicable provisions of the State of Florida Corporation Code shall be distributed by the corporation to another nonprofit benefit corporation whose primary purpose is education or shall be distributed to the federal government, or to a state or local government, for public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
