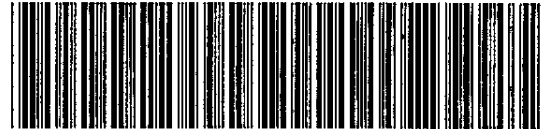

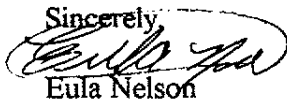

**\*\*\*\*INSERT ARTICLE XI - FISCAL YEAR \*\*\***

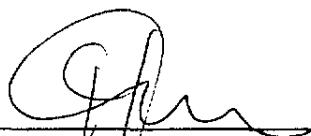
