ARTICLES OF INCORPORATION
OF

ARTICLE - NAME

The name of this corporation is: **POWER OF DELIVERANCE APOSTOLIC ARK MINISTRIES, INC.**

The principal place of business is: 2849 NW 53rd Terrace, Sunrise, Fl. 33313

ARTICLE 11 - DURATION

This Corporation shall be: **PERPETUAL**

ARTICLE 111 - PURPOSE

The purposes for which this corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

This corporation is a **NON PROFIT** Corporation and is not organized for the private gain of any person. It is organized under the nonprofit Public Benefit Corporation Law for charitable purposes.

ARTICLE 1V - SPECIFIC PURPOSE

The specific purposes of this corporation are:

1. To cultivate, promote and extend the teachings and practices of the Bible.
2. To receive Tithe, Offerings, Gifts, and Bequests, in order to promote the purpose of the corporation.
3. To exercise all rights and powers conferred by the laws of the State of Florida upon Non-Profit Corporations.

4. To erect and maintain a building or buildings for the above purpose and to engage in any operation incidental to and essential to carry out the purpose above mentioned.
5. To solicit funds and donations in kind and from time to time to further the purpose of this corporation.
6. To acquire and receive by purchase, donation or otherwise, any property, real, personal or mixed, and to hold, use and dispose of the same.
7. To borrow money and to issue evidence of indebtedness in furtherance of any or all of the object of this business, and to secure loans by mortgage, pledge, deed of trust, or other lien.

ARTICLE V - REGISTERED AGENT

The initial Registered Agent name and address is: Evangelist Imogene Y. Johnson,

ARTICLE VI - ORGANIZATION

- This corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office.

ARTICLE VII - CORPORATE ASSETS

Upon the dissolution of the Corporation, assets remaining after payment, or provision for payment, of all debts and liabilities of this Corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes, and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code.

ARTICLE VIII - DIRECTORS

The initial Board of Directors will consist of three (3) members. The number of directors

may be increased or decreased by amendment of the bylaws, but, shall in no case be less than three (3). Directors shall be elected by the Members at the annual meetings and shall serve until their successors have been elected and qualified.

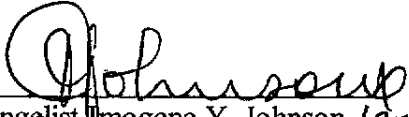

ARTICLE X - DISSOLUTION CLAUSE

DISSOLUTION CLAUSE: Upon the dissolution of the corporation, the Board of Trustees shall, after paying or making provisions for the payment of all the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Trustees shall determine. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

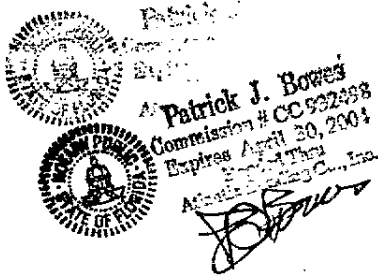
