for

ARTICLE ONE: NAME

The name of the proposed corporation shall be Panama City Christian School, Inc.

ARTICLE THREE: EXISTENCE

The corporation shall exist perpetually unless dissolved according to law.

ARTICLE FOUR: GENERAL NATURE OF BUSINESS

The purpose of the said corporation is to conduct all religious, charitable, and educational activities in connection with a Christian school.

The powers of Panama City Christian School, Inc. are limited to those within the scope of section 501 (c) (3) of the Internal Revenue code of 2001 of the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, Panama City Christian School, Inc., shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under section 501 (c) (3) of the Internal Revenue Code of 2001 or the corresponding provision of any future United States Internal revenue law.

ARTICLE NINE: FUTURE DISTRIBUTION OF THE ASSETS

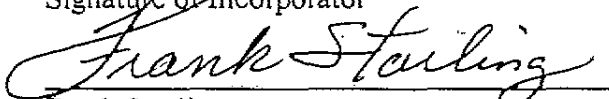

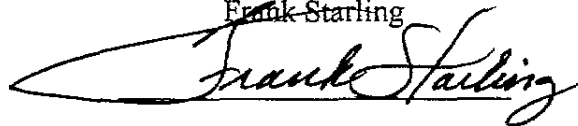
