TO

ARTICLES OF INCORPORATION

Pursuant to the provisions of Chapter 617 of the Florida Statutes, this corporation adopts the following Articles of Amendments to its Articles of Incorporation:

First: Article I is hereby repealed and replaced as follows:

Article I the name of the corporation is: 2421-2423 NW 99^{TR} TERRACE TOWNHOME ASSOCIATION, Inc.

Second:

Article VII is hereby repealed and replaced as follows:

ARTICLE VII BOARD OF DIRECTORS

A. The number of directors on the Board of Directors shall be four (4). The number of Directors elected by the Memhers at and subsequent to the Majority Election Date shall be as provided in Paragraph C and D of this Anticle VII.

 - There shall be only one (1) vote for each Director.
 - In the case of deadlock by the Board, application shall be made to a court of competent jurisdiction to resolve the deadlock.


