**ARTICLES OF INCORPORATION OF
FAITH~2~FAITH MINISTRIES ASSOCIATION & INTERNATIONAL, INC.**

The undersigned incorporator, for the purpose of forming a not for profit corporation under Chapter 617 of the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be:

Faith~2~Faith Ministries Association & International, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III: SPECIFIC PURPOSE

Faith~2~Faith Ministries Association & International, Inc. was founded in Coconut Creek, Florida, as an outreaching ministry of Scotty Allen Ministries. The primary purpose of Faith~2~Faith Ministries Association & International, Inc. is to provide leadership and fellowship service to the Body of Christ Jesus known as the Church in whole.

In recognizing the unity of the entire Body of Christ and specifically the ministry gifts God has set in the Church as described in Ephesians 4:11,12, 1 Corinthians 12:28, and Romans 12:4-8, Faith~2~Faith Ministries Association & International, Inc. declares itself strongly in support of the supernatural ministries and operations of in the members.

Faith~2~Faith Ministries Association & International, Inc. is an outreach organization to help establish maturity in the Body of Christ; govern its members; assist churches by any means construed to the offices of promoting the gospel; provide counsel in various areas of ministry, such as but not limited to, Preaching, Teaching, Baptism, Marriage, Funeral Service.

Faith~2~Faith Ministries Association & International, Inc. shall meet regularly upon availability, to provide its members an opportunity for fellowship, as well as giving and receiving direction, vision, and valuable information that will lead to more effective

ministry. The primary purpose of Faith~2~Faith Ministries Association & International, Inc. will be to carry out the mandates of faith by Evangelism, publishing, and religious broadcasting. This ministry will be involved in spreading the Gospel of Jesus Christ by traveling, meeting in convention halls, meeting halls, church's across the nation and internationally around the world. We will endeavor to spread the Gospel by the Printed page, Radio, T.V. or by any media that is available or that will become available in the future.

Faith~2~Faith Ministries Association & International, Inc. adheres to Biblical standards of righteousness in ministerial and personal conduct in accordance with the Scriptures: "Therefore if any MAN be IN CHRIST, he is a NEW CREATION, old things are passed away. Behold All THINGS are made new." (II Corinthians 5:17) and "Follow peace with all men, and HOLINESS, without which no man shall see the Lord" (Hebrews 12:14).

ARTICLE IV: APPOINTMENT OF DIRECTORS

An Executive Administrative Board shall consist of not less than three and not more than ten directors appointed by the President. Each director shall hold a valid belief in accordance with the tenets of faith of this Ministry.

The term of office for each Board member shall be perpetual from the date appointed, or a member may be rotated off the Board at intervals determined by the President.

In the event of a vacancy on the Board, the President shall appoint a successor to fill the office.

The Officers of the Board shall be:

President

Executive Vice President

Vice President

Secretary-Treasurer

The Executive Vice President, who shall be Board Chairman, and Vice President shall both be appointed by the President.

The Board Chairman shall be responsible for presiding over all Board meetings and shall act as the Board representative to the President.

The Vice President shall be responsible to assist the Executive Vice-President and will fill the Executive Vice-President's office in case of vacancy until another appointment is made by the President.

The Secretary-treasurer shall be responsible to keep accurate records of the Meetings and Decisions of the Board. And shall be responsible for all funds received or delegated by the Board and shall supervise all financial records.

The Executive Administrative Board will meet on a regular basis. The locations and times of these meetings will be determined by the officers. Special board meetings may be called during the year, and all Board members are expected to respond upon reasonable notification of such called meetings. Upon approval of the president, a quorum present can execute administrative business.

ARTICLE V: DISCIPLINARY ACTIONS AND PROCEDURES

The Executive Administrative Board Does not sit in judgment of those who have made or will make mistakes but leaves judgment with God. If, however, a member's endeavors become seriously unethical, unscriptural, or controversial, the organization will counsel them in the spirit of Christ. All methods of reconciliation shall be conducted first, if unsuccessful, divine discipline will be in order. All members shall conduct themselves as divine Ambassador's of Christ.

ARTICLE VI: EXCLUSION

Any member refusing to adhere to sound counsel, correction, or discipline will be removed.

Causes for Expulsion include:

- 1.) Rejection in part or whole the Tenets of Faith held in common by the Ministry of FAITH~2~Faith Ministries.
- 2.) Practicing immorality (1 Corinthians 5:9-11)
- 3.) Walking in an unruly or disorderly manner (2 Thessalonians 3:6-12)
- 4.) Causing Divisions among the body of Christ (Romans 16:17)
- 5.) Defiling one's separation from the world (James 4:4)

ARTICLE VII: TENETS OF FAITH

The Holy Scriptures:

-The bible is the inspired Word of God, written by holy men of old who spoke and wrote as moved by the Holy Spirit. The New Covenant, as recorded in the New Testament, we accept as our infallible guide in matters of conduct and doctrine. (2 Timothy 3:16; 1 Thessalonians 2:13; 2 Peter 1:21).

The Godhead;

-Our God is one, Manifested in three persons, The Father, The Son, and the Holy Spirit, Being co-equal (Phil. 2:6).

-God the Father, is greater than all; The Sender of the Word (Logos) and the Begetter (John 14:28; John 16:28; John 1:14)

-Jesus the Son, is the Word, that has come in Flesh, The only Begotten, and has existed with the Father from the beginning (John 1:1, John 1:18, John 1:14).

-The Holy Spirit, proceeds forth from both the Father and the Son and is eternal (John 15:26).

Man, His fall and Redemption:

-Man is a created being, made in the likeness and image of God, but through Adam's transgression and fall, sin entered the world. "All, have sinned, and come short of the glory of God." And "As it is written, there is none righteous, no, not one." Jesus Christ, the Son of God, was manifested to undo the work of the devil and gave His life and shed His blood to redeem and restore man back to God (Rom. 5:14; Rom 3:23; Rom.3:10; 1 John 3:8).

Salvation;

-Is the gift of God to man, separate from works and of the law, and is made operative by grace through faith in Jesus Christ, producing works acceptable to God (Eph. 2:8)

Eternal Life and the New Birth;

~ Man's first step toward salvation is godly sorrow that worketh repentance. The New Birth is necessary to all men, and when experienced produces eternal life (Cor.7:10; 1 John 5:12; John 3:3-5).

Water Baptism;

~ Baptism in water is by immersion, it is a direct commandment of our Lord, and is for believers only. The ordinance is a symbol of the Christian's identification with Christ in His death, burial and resurrection. (Mat.28:19; Rom. 6:4; Col.2:12; Acts 8:36-39).

The following recommendation regarding water baptismal is adopted; to wit:

"On confession of your faith in the Lord Jesus Christ, The Son of God, and by His authority, I baptize you in the Name of the Father, and the Son, and the Holy Ghost. Amen."

Baptism in the Holy Ghost;

~The baptism in the Holy Ghost and fire is a gift from God as promised by the Lord Jesus Christ to all believers in this dispensation and is received subsequent to the New Birth. This experience is accompanied by the initial evidence of speaking in other tongues as the Holy Spirit Himself gives utterance (Matt.3:11; John 14:16-17; Acts 1:8; Acts 2:38,39; Acts19:1-7; Acts 2:4).

Sanctification;

~The Bible teaches that without holiness no man can see the Lord. We believe in the Doctrine of Sanctification as a definite, yet progressive work of grace, commencing at the time of regeneration and continuing until the consummation of salvation at Christ's return (Heb. 12:14; 1 Thess. 5:23; 2 Peter3:18; 2 Cor.3:18; Phil. 3:12-14; 1 Cor. 1:30).

Divine Healing;

~Healing is for the physical ills of the human body, and is wrought by the power of God through the prayer of faith and by the laying on of hands. It is provided for in the atonement of Christ, and is the privilege of every member of the Church today (Mark 16:18; James 5:14-16; 1 Peter 2:24; Matt. 8:17; Isa. 53:4,5).

Resurrection of the Just, & the Return of Our Lord;

~ His coming is imminent; the angels said to Jesus' disciples, "...this same Jesus...shall so come in like manner as ye have seen him go into heaven." When he comes; "...the dead in Christ shall rise first: then we which are alive and remain shall be caught up together with them in the clouds to meet the Lord in the air..." (Acts 1:11; 1 Thess.4:16, 17).

Following the Tribulation;

~He shall return to earth as King of kings, and Lord of lords, and together with His saints, who shall be kings and priests, he shall reign a thousand years (Rev.20:6)

Hell and Eternal Retribution;

~The one who physically dies in his sins without accepting Christ is hopelessly and eternally lost in the Lake of Fire and therefore, has no further opportunity of hearing the Gospel or repenting.

The Lake of Fire is literal. The terms "eternal" and "everlasting," use in describing the duration of the punishment of the damned in the Lake of Fire, carry the same thought and meaning of endless existence as used in denoting the duration of joy and ecstasy of saints in the presence of God (Heb.9:27; Rev 19:20)




