If you have suffered a personal injury as a result of a violent crime, you may be eligible for up to \$25,000 to assist in:

- * Medical/Dental * Mental Health Counseling
- * Wage Loss * Disability Allowance
- * Property Loss (elderly/disabled) up to \$500
- * Domestic Violence relocation
- * Funeral/Burial Expenses * Loss of Support

Crimes include but are not limited to:

- * DUI * Hit and Run *murder
- * Assault * Elder or child abuse
- * Domestic Violence and
up to \$1,000 relocation assistance

There is a special \$500 property loss fund for those over 60 and/or disabled. An example of how this has been used many times in the past is when mail boxes have been vandalized. The Center has contracted with someone to pick up the needed supplies, install the new box, and we file the claim for them. The client pays for the service and equipment directly to The Center but full reimbursement is received shortly from the victim compensation fund.

The criteria to qualify for compensation is:

- * report the crime within 72 hours to law enforcement (some exceptions apply)
- * you are an innocent victim and had nothing to do with the crime committed
- * cooperate with law enforcement and the prosecutor.
- * never been charged with a forcible felony

This is a FREE service that serves victims NATIONWIDE but contributions are always needed and appreciated in order to continue helping victims of crime.

If you have been an innocent victim of a violent crime within the past year you may be eligible for compensation. Contact The Center if you have questions or think you may be eligible.

Even if the case is not prosecuted by the State Attorney you may be able to file a civil suit. A lawyer can be located to assist you in this matter.

A speaker is available to come to any group. Contributions to help defray travel expenses are appreciated.

Donations and volunteers to set appointments to speak to area groups are welcomed and greatly appreciated.

Social Security claims can also be handled with the customary charges that are paid after your case is won. We have had great results with supposedly 'impossible' cases!
