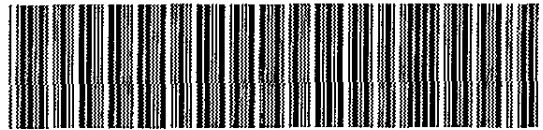

**ARTICLE I
NAME AND PURPOSE:**

THE NAME OF THIS ORGANIZATION SHALL BE THE OCALA RUGBY CLUB,
INC.

THE PURPOSE OF THE CLUB SHALL BE:

1. TO PROMOTE THE GAME OF RUGBY IN THE CITY OF OCALA AND
THROUGHOUT THE STATE OF FLORIDA.
2. TO COMPETE IN THE FLORIDA RUGBY UNION.
3. TO PROMOTE AN ATMOSPHERE OF FRIENDSHIP AND COMPETITIVENESS.

THERE WILL BE FOUR (4) DIRECTORS OF THE CLUB: PRESIDENT, VICE PRESIDENT, TREASURER AND MATCH SECRETARY.

PRESIDENT: THE PRESIDENT SHALL PRESIDE AT EACH MEETING AND BE IN CHARGE OF ORGANIZATIONAL PLANNING, CLUB ACTIVITIES, INSURANCE AND ACT AS SOCIAL CHAIRMAN.

VICE PRESIDENT: THE VICE PRESIDENT SHALL PRESIDE OVER MEETINGS IN THE EVENT OF THE PRESIDENT'S ABSENCE AND SHALL BE IN CHARGE OF ALL EQUIPMENT, BALLS, INVENTORY, UNIFORMS AND MEDICAL KIT.

TREASURER: THE TREASURER SHALL BE CUSTODIAN OF ALL CLUB FUNDS, DEPOSITING AND WITHDRAWING FUNDS FROM THE CLUB'S ACCOUNT AND KEEP ALL RECORDS PERTAINING THERETO. THE TREASURER IS RESPONSIBLE FOR REQUIRING THE SIGNATURES OF AT LEAST TWO EXECUTIVE COMMITTEE MEMBERS OF ANY CHECK WRITTEN FROM THE CLUB'S ACCOUNT.

MATCH SECRETARY: THE MATCH SECRETARY SHALL BE RESPONSIBLE FOR THE ORGANIZATION AND ARRANGEMENTS OF ALL CLUB GAMES WITH THE AGREEMENT OF THE EXECUTIVE COMMITTEE.

THESE DIRECTORS SHALL CONSTITUTE THE EXECUTIVE COMMITTEE FOR THE OCALA RUGBY CLUB, INC. EACH MEMBER ON THE EXECUTIVE COMMITTEE SHALL BE AUTHORIZED TO SIGN CHECKS ON BEHALF OF THE CLUB.

ARTICLE IV MEETINGS

THERE SHALL BE A MEETING OF THE EXECUTIVE COMMITTEE ONCE EVERY MONTH ON THE FIRST TUESDAY OF THE MONTH. THE PRESIDENT SHALL HAVE THE OPTION TO CALL FOR ADDITIONAL MEETINGS AS NEED ARISES.

ARTICLE V ELECTIONS

THE ELECTION OF DIRECTORS SHALL BE HELD ONCE A YEAR IN THE FALL.

ALL MEMBERS OF THE CLUB MAY VOTE IN AN ELECTION.

VOTING SHALL BE BY SECRET BALLOT.

DIRECTORS MUST BE ELECTED BY SIMPLE MAJORITY VOTE.

IF IN THE EVENT AN DIRECTOR CANNOT COMPLETE HIS/HER TERM THE PRESIDENT HAS THE AUTHORITY TO APPOINT A SUCCESSOR UNTIL A SPECIAL ELECTION CAN TAKE PLACE.

THE PRESIDENT MAY CREATE AND FILL ANY ADDITIONAL POST HE/SHE FEELS NECESSARY FOR THE CLUB WITH THE APPROVAL OF THE EXECUTIVE COMMITTEE.

ARTICLE VI FUNCTIONS

ANY MEMBER WHO ENGAGES IN ANY DANGEROUS, UNSAFE OR OTHER ACTIVITY WHICH BRINGS HARM, RIDICULE OR EMBARRASSMENT TO THE CLUB SHALL BE IMMEDIATELY REMOVED AS A MEMBER UPON MAJORITY VOTE OF THE EXECUTIVE COMMITTEE. IF THE MEMBER IS AN EXECUTIVE COMMITTEE MEMBER THE MEMBER CAN BE REMOVED BY A MAJORITY OF THE REMAINING COMMITTEE.

ARTICLE VII AMENDMENTS

AMENDMENTS TO THESE ARTICLES MAY BE MADE FROM TIME TO TIME UPON SUBMISSION TO THE CLUB MEMBERS AND APPROVED BY A SIMPLE MAJORITY OF THE MEMBERS PRESENT.

ARTICLE VIII COMMITTEES

THE PRESIDENT MAY CREATE AND APPOINT COMMITTEES AS HE/SHE FEELS ARE NEEDED.

ARTICLE VIV DISSOLUTION OF ASSETS

IN THE EVENT THAT THE CORPORATION SHOULD BE DISSOLVED ANY AND ALL REMAINING ASSETS WILL BE DONATED TO THE RONALD MCDONALD HOUSE IN GAINSVILLE, FLORIDA.
