AMENDMENTS TO THE ARTICLES OF INCORPORATION OF PIER 41 CONDOMINIUM ASSOCIATION, INC.

VIII. BY-LAWS

The By-Laws of the Association shall be adopted by the initial board of Directors. The By-Laws may be amended in accordance with the provisions thereof, except that no portion of the By-Laws may be altered, amended, or reseinded in such a manner as would prejudice the rights of the Developer of the Condominium or mortgagees holding mortgages encumbering units in the Condominium, without their prior written consent.

IX. AMENDMENTS TO ARTICLES

Amendments to these Articles shall be proposed and adopted in the following manner:

B. A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors, acting upon the vote of a majority of the Board of Directors, or by the members of the Association having a majority of the votes in the Association. In order for any amendment or amendments to be effective, same must be approved by an affirmative vote of 66-2/3% a majority of the entire Board of Directors and by an affirmative vote of not less than 66-2/3% of the members a majority of the eligible voting interests present, either in person or by proxy, at a duly called meeting of the members of the Association at which a quorum is present.

D. A copy of each amendment adopted shall be filed within ten (10) days of adoption with the Secretary of State, pursuant to the provisions of applicable Florida Statutes.
