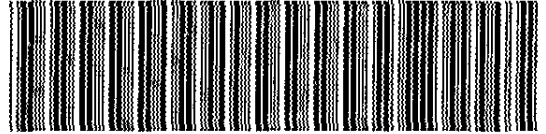

ARTICLES OF INCORPORATION
(Not For Profit)

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I – NAME

The name of the corporation shall be: HOMES FOR CHRIST MINISTRIES, INC.
INC.

ARTICLE II – PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 1399 SW 82 PLACE, MIRAMAR, FL 33025.

ARTICLE III – PURPOSE (S)

The specific purpose or purposes for which the corporation is organized is (are):

The ministry is geared and directed to lead all people into a divine encounter with our Lord and Savior Jesus Christ, the Son of the living God; to lead families in divine instructions through the infallible Word of God; to teach children and youths the oracles of God; to instruct married couples in the direction of our Lord; to empower the body of Christ into a deeper walk with God and to grow in the knowledge of His Word by the full auction of the Holy Spirit; to dedicate homes in the Name of our Father, His Son and the Holy Spirit; to hold prayer meetings and bible studies in homes as God provides His direction; to contribute in feeding the hungry, clothing the naked, visiting the widows, and healing the sick; to help meet the needs of the poor; to visit those in prisons; to reach lost souls through street evangelism; to preach good tidings unto the meek, bind up the brokenhearted, proclaim liberty to the captives, open the door to them that are bound in spirit, and to proclaim the acceptable year of the Lord; and to encourage those that mourn.

The fiscal year of the corporation shall end on the last day of the month of SEPTEMBER.

The purposes for which this corporation is incorporated are exclusive religious, charitable, scientific, literacy, and educational within the meaning of Section 501 (c) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue.

Notwithstanding, any other provision of these articles or subsequent amendments to these articles, this corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501 (c) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue Law.




