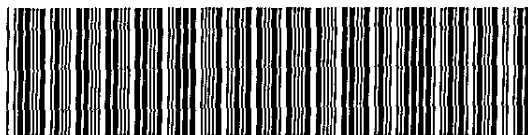

The method of electing directors of this corporation is as stated in the bylaws.


