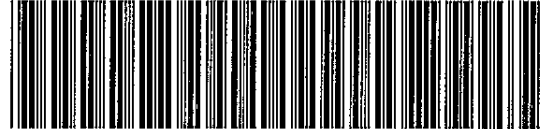

Amendment of Articles of Incorporation  
of  
Truth and Spirit Ministry, INC.

*The name of the corporation is: Truth and Spirit Ministry, INC.*

The Amendment includes the following content provision.

Article VIII

Said organization is organized exclusively for charitable, religious educational, and scientific purposes, Including for such purposes, the making of distributions to organizations that qualify as exempt organization under Section 501C(3) of the internal revenue code of corresponding section of any future tax code.

Article VX

Upon the dissolution of the organization, assets will be distributed for one (1) or more exempt purposes within the meaning of Section 501C(3) of the internal revenue code, or corresponding section of any future federal tax code, or corresponding section of any future federal tax code, or will be distributed to the federal government, or to a state or local government, for some public purposes. Any such assents not disposed of will be disposed of by the court of common pleas of *the county in which the principal office of the organization is then located, exclusively for such* purposes or to such organization or organization as said court will determine which are organized and operated exclusively for such purposes.
