ARTICLES OF INCORPORATION OF

CHARTER MILITARY SCHOOLS DEVELOPMENT CORPORATION

The undersigned incorporator, acting as incorporator of a corporation desiring to form a not for profit corporation under the provisions of Chapter 617 of the Florida Statutes, do hereby adopt the following Articles of Incorporation.

ARTICLE I-NAME OF CORPORATION

The period of duration of this corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon the filing of the Articles of Incorporation by the Department of State of Florida.

In the event of dissolution, the residual assets of the corporation will be turned over to one or more organizations which themselves are exempt organizations described in Section 510(c)(3) of the Internal Revenue Code or corresponding sections of any prior or future Internal revenue Code, or to the Federal, State or local government for exclusive public purpose(s).

ARTICLE IV - EDUCATIONAL CHARITABLE PURPOSE

The corporation is established as a not for profit corporation for the purpose of the development and creation of public military schools, both charter and "public" structured.

The corporation is organized only for charitable, religious, educational and scientific purposes as defined in Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended, including distributions to organizations that qualify as exempt under that Section 501 (c)(3) and specifically for the purpose of the development and creation of public military schools. Regardless of other provisions of these Articles of Incorporation, the corporation shall not carry on any activities not permitted for a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended. The Corporation shall not directly or indirectly perform any act or transact any business that will jeopardize the tax exempt status of the Corporation provided under the not for profit corporation laws of the State of Florida and
